The Centre Approval Fee is a one-off fee which covers the cost of application review. The Centre Approval Fee is non-refundable. Centres will have the opportunity to gain approval for up to 5 qualifications within the initial approval, if Centres would like to add more qualifications, these are chargeable, see below.

Annual Approval Fees will be chargeable annually. Annual fees are non-refundable. They include 1 EQA visit per year.

Sampling

The initial sampling of learner work is included within the registration fee. In some instances, it may be deemed necessary to re-sample learner work based on feedback, actions and returning learner work to centres to review.
